11	<=10.0 L	Kegs-\$5 Deposit	\$5	\$0.00	Any	Refillable stainless steel/aluminum container designed primarily for commercial use. The \$5 deposit is administered by the LDB on behalf of the industry.

Pub kegs are 20L bottles encased in a plastic cylinder. Petainer kegs 20 or 30 L bottles encased in a cardboard cylinder.
